PRIVACY STATEMENT

NEXUSICO LLC., (THE COMPANY) PLACES HIGH PRIORITY ON THE PRIVACY AND INTEGRITY OF THE PERSONAL INFORMATION OF OUR CLIENTS, BOTH PRESENT AND FUTURE AND OTHER VISITORS TO THE SITE. THE COMPANY STRIVES TO ENSURE THE SAFETY AND CONFIDENTIALITY OF ALL INFORMATION RECEIVED FROM THE CLIENT. THIS PRIVACY POLICY (THE "POLICY") DESCRIBES HOW THE COMPANY COLLECTS, USES AND PROTECTS THE PERSONAL INFORMATION OF THE CLIENT. BY ACCESSING THE SITE AND THE SERVICE, YOU CONSENT TO THE COLLECTION AND USE OF INFORMATION AS DESCRIBED IN OUR PRIVACY POLICY, AS MAY BE AMENDED BY US FROM TIME TO TIME.

2. PERSONAL INFORMATION

TO OPEN A BUSINESS ACCOUNT, THE COMPANY MAY NEED CERTAIN INFORMATION (PERSONAL DATA) ABOUT THE CLIENT. THIS MAY INCLUDE:

- INFORMATION PROVIDED ON APPLICATIONS AND OTHER COMPANY FORMS, SUCH AS NAME, ADDRESS, DATE OF BIRTH, PASSPORT DATA AND OCCUPATION.
- FINANCIAL INFORMATION SUCH AS INCOME, ASSETS, INVESTMENT EXPERIENCE.
- DOCUMENTS PROVIDED TO CONFIRM IDENTITY, SUCH AS PASSPORT, UTILITY BILLS, AND/OR BANK STATEMENTS OR COMPANY INCORPORATION INFORMATION.
- PAYMENT DOCUMENTS LIKE MONEY TRANSFER ORDERS, BANK STATEMENTS, BANK CARD COPIES, ETC

3. TRANSACTIONAL INFORMATION

THIS INFORMATION INCLUDES DEALS MADE BETWEEN THE CLIENT AND THE COMPANY, OR BETWEEN THE CLIENT AND THE AFFILIATED PARTNERS OF THE COMPANY, AS WELL AS COMMUNICATIONS (UNILATERAL OR BILATERAL) BETWEEN THE PATRON AND THE COMPANY. EXAMPLES INCLUDE CLIENT ACCOUNT BALANCES, INVESTING ACTIVITY, CLIENT INQUIRIES, THE COMPANY RESPONSES, INCLUDING EMAILS OR LOG-FILES USED IN MESSAGING SYSTEMS. IN THE PRIVACY POLICY, ORGANIZATIONS OWNED BY THE COMPANY AND ORGANIZATIONS THAT ARE PART OF THE COMPANY PROPERTY ARE REFERRED TO AS "AFFILIATED PARTNERS OF THE COMPANY."

4. VERIFICATION INFORMATION

INFORMATION NECESSARY TO VERIFY PATRON IDENTITY SUCH AS A PASSPORT OR DRIVER'S LICENSE (OR ARTICLES OF ASSOCIATION IN CASE THE PATRON IS A LEGAL UNIT). VERIFICATION INFORMATION INCLUDES THE INFORMATION RECEIVED BY THE COMPANY FROM SOURCES SUCH AS LOAN OFFICES, ADDRESS BUREAUS, INFORMATION AGENCIES, OR OTHER ENTITIES THAT ARE NOT AFFILIATED WITH THE COMPANY

5. SUBSCRIPTIONAL INFORMATION

INFORMATION SUCH AS SIGNALS, ALERTS, NEWS CATEGORIES, AND PRICE SUBSCRIPTIONS.

6. SECURITY

NEXUSICO CAPITAL LLC., TAKES ALL NECESSARY MEASURES TO PROTECT THE PERSONAL DATA OF THE USER FROM UNAUTHORIZED ACCESS BY THIRD PARTIES. ALL THE INFORMATION OUR CLIENTS PROVIDE ARE STORED ON SECURE SERVERS, STRENGTHENED BY SSL TECHNOLOGY TO ENCRYPT TRANSACTIONAL INFORMATION. A PASSWORD IS PROVIDED TO YOU (WHICH YOU MAY CHANGE) THAT ENABLES YOU TO ACCESS CERTAIN PARTS OF OUR WEB SITE; YOU ARE RESPONSIBLE FOR KEEPING THIS PASSWORD CONFIDENTIAL. WE INSIST YOU DO NOT SHARE THE PASSWORD WITH OTHERS. EVEN WITH THE BEST SECURITY MEASURES, TRANSFER OF INFORMATION THROUGH THE INTERNET IS NOT FOOL PROOF, THE 'COMPANY' DOES NOT GUARANTEE THAT SAFETY IN THIS REGARD. THE COMPANY SHALL NOT BE LIABLE TO ANY DAMAGE THAT OCCURS WITH BREACH OF TRANSACTIONAL SECURITY. FOLLOWING ARE THE PERSONAL SECURITY CLAUSES WHICH APPLY TO ALL CLIENTS.

- THE USER IS REQUESTED TO KEEP THEIR PASSWORDS SAFE AND IN SECRET AND NEVER TO SHARE IT WITH OTHERS.
- IF A PASSWORD IS COMPROMISED OR IF THE USER FORGETS THE PASSWORD, SAME COULD BE REQUESTED ON THE USER LOGON PAGE. UPON CONFIRMING THE EMAIL ADDRESS, A PASSWORD RESET LINK WILL BE SENT TO THE REGISTERED EMAIL ADDRESS AND THE USER IS PROMPTED TO CHANGE PASSWORD.
- THE USER CONTROLS THE FLOW OF ALL THE PERSONAL INFORMATION WHEN USING OUR SITE.
- THE COMPANY RESERVES THE RIGHT TO TERMINATE THE ACCESS OF ANY USER WHO BREAKS THIS USER AGREEMENT, INCLUDING SUSPENSION OF ACCESS TO THEIR PERSONAL DASHBOARD.
- THE USER WHOSE INFORMATION CEASES TO BE VALID AND WHOSE ACCESS HAS BEEN TERMINATED WILL HAVE NO RIGHT TO CREATE A NEW ACCOUNT (INCLUDING USING THE EMAIL ADDRESS USED EARLIER) WITHOUT AUTHORIZATION FROM THE COMPANY.
- DURING THE USE OF SERVICES OF THE COMPANY (INCLUDING THE REGISTRATION, INTERACTING WITH OTHER USERS THROUGH THE INTERFACE OF THE NEXUSICO CAPITAL LLP SERVICE, ADVERTISING, BROWSING OF THE WEB PAGES OF NEXUSICO CAPITAL LLP SERVICE AND SO ON), THE USER VOLUNTARILY DECIDES TO PROVIDE THEIR PERSONAL DATA AND OTHER INFORMATION SUCH AS LAST NAME, NAME, MIDDLE NAME, EMAIL ADDRESS, MOBILE PHONE NUMBER AND ALSO ANY OTHER INFORMATION PROVIDED BY THEM INCLUDING THE MESSAGES SENT TO OTHER USERS VIA THE CONTACT FORM AT THE INTERFACE OF THE COMPANY. THE USER HEREBY DECLARES THEIR CONSENT TO THE PROCESSING OF THE DATA BY THE COMPANY AND ITS ASSOCIATES.

7. SCOPE OF THE POLICY AND THIRD-PARTY SITES

THIS POLICY APPLIES ONLY TO US AND THIS WEBSITE. WE DO NOT EXERCISE CONTROL OVER OTHER WEBSITES OR OVER BANNERS OR LINKS FROM WITHIN OUR WEBSITE. THESE OTHER WEBSITES, BANNERS OR LINKS MAY PLACE THEIR OWN COOKIES TO COLLECT DATA FROM YOUR COMPUTER OR REQUEST YOUR PERSONAL INFORMATION. WE RECOMMEND YOU TO READ THEIR PRIVACY POLICIES AND OTHER TERMS OF SUCH THIRD PARTIES BEFORE ACCESSING OR USING THEM.

8. CHANGE PROCEDURES

ANY AMENDMENTS AND/OR ADDITIONS TO BE MADE, THE COMPANY SHALL INFORM THE CLIENTS BY POSTING NOTICES ON THE COMPANY'S WEBSITE AND SENDING A PERTINENT MESSAGE THROUGH THE INTERNAL MAIL SYSTEM. RELEVANT NOTICE POSTED ON THE COMPANY WEBSITE AND MESSAGES THROUGH INTERNAL MAIL ARE CONSIDERED TO BE ADEQUATE.

THE AMENDED DOCUMENT WILL BE EFFECTIVE AFTER 5 (FIVE) BUSINESS DAYS (120 HOURS) FOLLOWING THE PUBLICATION OF THE NOTICE ON THE COMPANY WEBSITE.

THE AMENDED DOCUMENT WILL BE APPLICABLE TO ANY ACCOUNTS REGISTERED AFTER ITS PUBLICATION. THE AMENDED DOCUMENT IS APPLICABLE TO TRADE ACCOUNTS THAT WERE REGISTERED PREVIOUS TO THE DATE THE DOCUMENT IN QUESTION WENT INTO EFFECT.

IN THE CASE THAT THE RULE OF LAW IS INTRODUCED, WHICH REQUIRES A CORRESPONDING AMENDMENT AND/OR ADDITION TO THE PRESENT PRIVACY POLICY, THEN THE RULE OF LAW SHALL BE APPLIED IMMEDIATELY AFTER THE EFFECTIVE DATE OF THE RELEVANT STATUTORY ACT, WHETHER THE REQUIRED AMENDMENT IS MADE OR NOT. REGULATIONS OF THE PRESENT PRIVACY POLICY THAT CONTRADICT THE NEWLY INTRODUCED RULE OR LAW BECOME VOID ONCE THE CORRESPONDING CHANGES TO THE DOCUMENT MENTIONED ABOVE GO INTO EFFECT.
